



Bishopsgate provide what is known as an "umbrella" solution which is a simple and hassle-free PAYE option utilised by many independent contractors working on multiple short-term contracts for agencies or end clients that require their project income to be handled at source.

Bishopsgate Employment Services will employ workers and process project income under Pay as You Earn (PAYE) managing the Tax and National Insurance (NI) deductions, ensuring tax compliance within the supply chain.





If you are involved in construction, you'll want to read this!

The Construction Industry Scheme (CIS) refers to a tax regime set out by HM Revenue & Customs (HMRC) to cater for self-employed contract workers in the construction industry.

As a result of the amendment made to section 44 of the Income Tax (Earnings & Pensions) Act (often labelled the agency legislation) there are now stricter rules surrounding the employment status of contractors, with the burden of proof over a lack of supervision, direction or control now resting with the agency.

Bishopsgate Agency CIS services specialise in the processing of payments to subcontractors working within the construction industry. The benefits of this service include:

- » Reduced administration as Bishopsgate takes care of invoicing, payment and issuing statements to subcontractors.
- » CIS Statements are provided for all payments made.
- » Access to health and safety advice.

Bishopsgate Agency CIS services allow you to remove the extra levels of administration taken on when engaging with CIS subcontractors.

You will be able to receive a singular invoice when needing to pay multiple subcontractors taking away the responsibility and additional administration required for UTR verification, Right To Work checks and necessary insurance cover.







Supervision, direction and control (SDC) assessments

In 2014 the construction industry had introduced the first round of supervision, direction or control assessments.

If a contractor was deemed to be subject to any of these three categories, they could no longer be a part of the Government's Construction Industry Scheme (CIS) and had to be paid under a PAYE scheme.

In 2016, the SDC legislation came into effect across the whole of the UK, not just within the construction industry. Agencies became accountable for carrying out SDC status determinations as to the manner of which the candidates' services were supplied to confirm how that individual could be engaged compliantly.

Specifically, each component:

Supervision – to apply there must be someone who is overseeing the work to make sure that what is being done is to the required standard of that task.

Direction – involves someone telling another person to do their work a certain way. The person providing direction, guidance, advice or instruction as to how the work is done as it is undertaken.

Control – where someone dictates what work a person does and how they should go about carrying it out. This also includes the power to move the worker from one task to another.

If a contractor falls in to any one of the above components, they are likely to be caught by SDC.

IR35

Introduced in 1999, IR35 was created to combat tax avoidance whereby workers and businesses capitalised on engaging with one another via an intermediary when in fact, would have been treated as an employee if an intermediary was not used in that instance.

The new 'off-payroll' legislation which was initially introduced into the public sector in 2017 but then extended into the private sector in 2021, means that the end client is required to carry out an IR35 status determination as the tax liabilities now fall on clients and agencies if inaccurate.

Right to Work
