



As your employer we must automatically enrol you into a pension scheme and make contributions. **Click here for more info from gov.uk**

Auto enrollment applies after being employed for 12 weeks.

Details will automatically be provided to NEST once your 12-week engagement has surpassed.

You won't be able to opt out until you've been enrolled and you have received your NEST ID which will be on the letter they will send to you. Once you've received your NEST ID there are mulitple ways to opt out.

You can:

- » opt out online at nestpensions.org.uk/optingout
- » call NEST's automated telephone line 0300 020 0090
- » request a paper opt-out form from NEST and then fill it in and send it back to us.

If funds have been paid in to NEST but you chose to opt out, these funds will be returned through salary payments.




